1. The City Secretary is authorized to issue permits, upon application, therefore allowing the applicant to keep poultry in the City.
2. The application must set forth the location in the City where livestock will be kept within the city limits of Lefors, and **must be signed by the property owner and the applicant, if different.** There will be a **\$10.00 fee for filing the application, non-refundable.**
3. A permit, if issued, shall allow the person to whom it is issued to keep livestock in the city for one year following issuance, upon the payment of a **permit fee of \$100.00**, and upon a determination by the City Secretary and City Marshal that the applicant has complied with the provisions of Ordinance Number 021001.
4. The permit shall authorize the keeping of livestock only under the following conditions:
  - a. No pigs or swine of any kind with the exception of miniature of potbelly pigs.
  - b. A minimum of 1000 square feet of ground space shall be provided for each animal. (*Attach any supporting documentation*)
  - c. No livestock shall be allowed on any part of the premise which is closer than 50 feet to the exterior limits of the nearest dwelling occupied by any person other than the permit holder.

5. A permit issued shall automatically renew for subsequent periods of one year, upon payment of a \$100.00 renewal fee established by ordinance.
6. All provisions of Ordinance Number 021001 must be met and followed or a complaint will be filed with the City Judge.
7. A permit issued may be revoked at any time if 1) the City Council by ordinance provides, or 2) the City Marshal and/or their designee determines that livestock are being kept in violation of this ordinance or the conditions of the permit.

I have been given a copy of Ordinance Number 021001 and have read and understand the regulations regarding keeping livestock in the City of Lefors.
