Larry Franks addressed the Council during public comments stating that the City uses public funds and to use common sense between wants and needs.

City Judge Kurt Curfman submitted a written report: For the month of April 2021, we had receipts of \$711.00. There was 1 new complaints or citation filed with the Court from the Marshal. This was for city ordinances. At this current time, we have outstanding balance of fines and court costs due the City of Lefors of \$5,874.55. All local, state, and federal reports are current at this time.

Councilwoman Miller made a motion to approve the consent agenda including reports, minutes from the April 12, 2021 regular meeting and bills to be paid. Councilman Gee seconded. Vote unanimous. Motion passed.

Councilwoman Miller made a motion to approve the audit as presented by April Foard with Foster & Lambert. Councilman Gee seconded. Vote unanimous. Motion passed.

Councilman Gee made a motion to approve up to \$275,000 to purchase a trash truck and to apply for financing with the bank. Councilwoman Miller seconded. Vote unanimous. Motion passed.

Consideration of sanitation contract with Wasteco was tabled until next meeting.

Councilman Gee made a motion to approve Ordinance No. 2021-0510, an Ordinance concerning the operation and use of golf carts and prohibiting the use of off-highway vehicles within City limits. Councilwoman Miller seconded. Vote Unanimous. Motion passed.
