

MINUTES
Lefors City Council Meeting
July 12, 2021 - Regular Session

The meeting was called to order at 7:01 p.m. by Mayor Michael Ray. Present were Council members James Gee, Keith Franks, Codi Hess, and Aaron Hunt. Council member Savannah Kingcade was absent.

Mayor Ray led the Pledge of Allegiance. Councilman Gee said the Invocation.

Public Works Director/City Marshal, Landon Roberts, submitted written reports: Sewer: We installed new floats for the inflow at plant pumps. We are cleaning the plant up. Currently getting all equipment on a maintenance schedule. All tests are being done and filled out daily. We are getting lots of rocks, sand, rags, plastic bottles, and foreign objects through the sewer system. Water: We have had or currently have water leaks at following locations: 100 Blk E. 3rd St., 600 Blk of Gulf St., 200 Blk E. 4th St., 600 Blk W. 3rd St., Tina's Mini Mart. All these leaks have been repaired or currently being worked on. We have been blowing down fire hydrants, so far 5 in total. Gas: No Gas Leaks currently. Work Order Status: We have completed 13 work orders this month. We currently have 20 open work orders.
