

**MINUTES**  
**Lefors City Council Meeting**  
**August 9, 2021 - Regular Session**

The meeting was called to order at 7:02 p.m. by Mayor Michael Ray. Present were Council members James Gee, Savannah Kingcade, Codi Hess, and Aaron Hunt. Council member Keith Franks was absent.

Mayor Ray led the Pledge of Allegiance. Councilman Gee said the Invocation.

No public comments made.

Judge Kurt Curfman submitted a written report: For the month of July, we had \$190.00 in receipts and eleven new complaints or citations filed with the Court from the Marshal. Currently, we have an outstanding balance of fines and court costs due the City of Lefors of \$9,974.00. All local, state, and federal reports are current at this time.

Public Works Director and City Marshal, Landon Roberts, submitted a written report: Sewer Report: We had to install a new chlorine injector at sewer plant. We repaired a section of pipe in the 500 blk E. 5th street. We have been flushing mains with water trucks to move all the foreign objects from lines and cleaning out manholes, cleaning up plant, hauling off old junk and tree limbs. We are still getting lots of rocks, sand, rags, plastic bottles, and foreign objects through the sewer system. Water Report: We have had or currently have water leaks at following locations: 300 blk Magnolia, Tina's Mini Mart, 6th & Mclean, Storage tank. All these leaks have been repaired or currently being worked on. We have been blowing down fire hydrants, so far 6 in July. Three Leaks have been repaired so far. Cleaning up around water wells. Gas Report: No Gas Leaks currently. Work Order Status: We have completed 9 work orders this month. We currently have 20 open work orders. July 2021 Lefors City Marshal Office Report: 1 Arrest, 8 Traffic Stops, 11 Traffic Citations, 30 COV Notices, 2 Agencies Assist.

Councilman Hunt made a motion to approve the consent agenda, which includes minutes of the July 12, 2021, regular meeting, bills, and department reports. Councilman Gee seconded. Vote unanimous. Motion passed.

Council reviewed and discussed the proposed budget for fiscal year 2021-22.


Councilwoman Kingcade motioned to set the proposed tax rate at \$0.95/\$100 evaluation. Councilwoman Hess seconded. Kingcade-For, Hess-For, Hunt-For, Gee-For. Vote unanimous. Motion passed.

Councilwoman Kingcade motioned to set a public hearing for the proposed tax rate and budget for August 30, 2021, at 7:00 p.m. Councilman Gee seconded. Vote unanimous. Motion passed

Councilwoman Hess made a motion to adjourn the meeting. Councilman Gee seconded. Vote unanimous. Motion passed.
